E - 1 100% Engraved
E - 2 Engraved with a supplementary process
- Category F** Miscellaneous Items for Business or Industry
F - 1 100% Engraved
F - 2 Engraved with a supplementary process
- Category G** Social Items; Invitations; Announcements
G - 1 100% Engraved
G - 2 Engraved with a supplementary process
- Category H** Holiday Greeting Cards
H - 1 100% Engraved
H - 2 Engraved with a supplementary process
- Category I** Engraving Company Self Promotion Pieces (Must be new in 2019)
- Category J** Andrew F. Coppolo Award for Technical Excellence

**Note: Entries in Categories A through C must be an Identity System, consisting of 2 or more items.
Example: Letterhead, Envelope, Business Card, etc.**

ENTRY RULES AND INSTRUCTIONS

1. The competition is open to all engravers, whether a member of this Association or not. The entry fees are as follows:

IEGA Member

First entry: \$45.00
Additional entries: \$20.00 each

Non-IEGA Companies

First entry \$60.00
Additional entries: \$30.00 each

2. Submit a separate entry form for each category. Please fill out the entry forms as completely as possible by typing or printing all information. Be sure to indicate the category letter in the box at the top of each entry form.
3. Send **four** unmounted samples of each entry, three unmarked, with the fourth set bearing the company name and address on the back with the enclosed entry form to:

4. All entries are due **January 18, 2020**. Judging will take place on February 5.
5. Entries must have been produced, delivered and billed between January 1, 2019 and December 31, 2019. Submitting company must have made the dies or stamped the impressions submitted.
6. Entries arriving in a defective condition will not be considered. All entries submitted become the property of the Association. Rules, judges and judging decisions are under the direct approval of the IEGA Board of Directors and all rulings are final.
7. For this contest, supplementary processes include foil, offset or letterpress printing, silk screen, blind embossing or other processes that compliment engraving.

The IEGA Award of Excellence

Awarded to the entry judged

Judging

The panel of judges, experts in engraving, design and related arts, will employ a point scoring system to determine the winning entries on the basis of the following standards:

1. Quality of reproduction from a technical viewpoint.
2. Excellence in design, art lettering and general composition.
3. Effectiveness of the entry for its intended purpose.
4. Self Promotion entries will not be eligible to win Best of Show.

Presentation of Awards

The first public announcement of the awards will be made at the 80th Annual Conference of the International Engraved Graphics Association. All engravers are encouraged to attend the Conference sessions and the Awards Dinner to be held during the Conference, February 19-22, 2020 at the Doubletree Downtown Hotel in Nashville, TN.

Purpose of the Contest

To make all advantages, features and capabilities of engraved products better known to all types of buyers. To provide an additional incentive for those who create and produce new ideas, techniques and applications of engraving. To recognize and appropriately honor those responsible for design, creation and production of engraved products of outstanding merit and distinction.
